**Scout groups may schedule range use in April, May, October, and November, depending on availability.**

**Mandatory Leader Orientation with an ISRA Scout Liaison at least 60 days prior to your requested event.** Your paperwork will be discussed at that time. Ranges 2 (25/50yard), 6 (shotgun), 7 (archery) and Black Powder demo/shoot can be requested for your use pending availability. No other ranges will be available for scout groups.

Must have 1 NRA Certified Instructor per discipline and 1 NRA Certified Range Officer per discipline.  
Both are available through the ISRA.

Scouts may borrow ISRA .22 rifles and shotguns at no charge. Group must furnish their own targets and factory ammunition. Only paper targets are approved for rifle; clays for shotgun. Leaders must have valid FOID cards to check out firearms. Your APPROVED firearms may also be used.

Eye and Ear protection is mandatory – available through ISRA at no charge.

Camping is permitted in designated areas only. Please remain in designated areas at all times – **anyone not in designated area will be immediately removed from the Range.**

Assigned Range(s) are for scouts only (parents may participate with scouts). **All other ranges are off limits.** 1 Parent per 5 Scouts. No scouts should be moving between ranges or clubhouse without an adult leading the group.
