There will be a break between the .22 and CF matches and another after CF as a lunch break. The .45 match will commence after the 1-hour lunch break. Immediately following the .45 match, the CMP EIC (.45&.22) & NRA Distinguished Revolver matches will be fired.

REGISTRATION FEE: Registration fee is \$15.00 per match - \$5.50 of this goes to the NRA and \$2.00 to the ISRA. Across the board fee is \$45.00 made payable by cash or by check (payable to the ISRA). ENTRIES: Entries will be limited to (80) competitors, 1 relay of (40) competitors per day. Competitors will fire the entire match in one day. Advanced entries received by the Saturday before the match will be confirmed by email/telephone. Post entries will be accepted to range capacity. Preference will be given to across the board entries.

FACILITIES: (40) raised and covered firing points. Line is poured concrete, controlled by loudspeakers. Targets are electrically operated. Potable water and restrooms are available at the range

Overnight camping, without hook-ups is permitted on the range. If you are not a range member, and plan to camp, please advise giving approximate arrival time, so we can make arrangements to have the gate open. Please arrive by 5:00pm if possible.

A box lunch w/ water will be provided or you can bring your own lunch **CMP SERVICE PISTOL MATCHES:** The CMP Service Pistol Match (Leg / EIC Match) for Credit toward Distinguished designation (.45 & .22) will be fired each day after the .45 caliber - Rapid Fire match. Entry fee is \$15 per pistol (.22 and 9mm/45).

NRA DISTINGUISHED REVOLVER MATCH: The NRA Distinguished Revolver match for credit toward the Distinguished Revolver badge will be fired each day after the service pistol match. Entry fee: None

2023 Illinois State Pistol Championship EIC Pistol Match Program

CMP Service Pistol and (.22) Pistol Matches sponsored by ISRA

Time & Date: August 12&13 2023 ** Will be fired at the end of the (2700) match - each day. (Service Pistol - 9mm or .45cal) and (** To Include the new 2015 EIC (.22) Pistol match)

Eligibility: You need not be a member of the NRA or a CMP affiliated club to participate

Fee: \$15.00 per match (9mm/.45 = \$15) and (.22 = \$15) = \$30.00 for both.

Course of Fire: 30 round National Match Course of Fire and CMP Section (7.1.2 for 2015 New Rimfire - firing position rules!)

Firearm: "Service Pistol" as defined in the Current Edition of the 2015 CMP Rule book. Competitors must use a pistol that was issued by the US Armed Forces or a commercial pistol of the same type and caliber: US pistol cal. 45, M1911, M1911a1 or US pistol cal. 9mm, M9, having not less than four (4) pounds trigger pull as prescribed in CMP competition rules. See attached list of CMP approved Service Pistols from Table 3, CMP Competition Rules for Service Pistol. The Standard Small-bore Pistol -NOTE: New CMP Rules: Section 6.4 (et al) - (.22 cal. Rimfire) pistol -must have Iron Sights (Optical Sights Not Permitted), Extended or Adjustable Front Sights are Not permitted. The Trigger Pull - of at least (2 lbs.) And, "Any system of recoil control based on a compensator, barrel venting, barrel- porting or other recoil reduction system operating in a similar manner is prohibited".

Ammunition: Competitors using a 45 caliber pistol may use any safe ammunition with metal jacketed bullets. Competitors using a 9mm pistol may use any safe ammunition with metal jacketed bullets. .22 Rimfire bullets must be at least 40 grains. Competitors will provide their own ammunition. Pistol triggers will be weighed and ammunition inspected by the Chief Range Officer. All decisions of the Match Director and/or Protest Committee are final.

Entries: There must be at least six (6) non-distinguished shooters to qualify the match for awards.

Awards: EIC points towards Distinguished Pistol Shot Badge. All awards and points will be issued by the CMP.

Rules: In accordance with the current edition of the CMP Rulebook. All EIC Service Pistol Matches will be governed by CMP Rules.

Pistol Approval Procedure. The CMP will maintain a current list of "CMP Approved Service Pistols" on its website at http://thecmp.org/comp etitions/cmp-pistol-program/. If a pistol is not listed in Rule 6.3.3 or 6.3.4 or on this "CMP Approved Service Pistols" list as an Approved Service Pistol and it appears to fulfill the requirements of Rule 6.3, a request may be submitted to CMP Competitions (competitions@thecmp.org) for the CMP to consider approving the pistol and adding it to the current list.

2023 Illinois State Outdoor Pistol Championship NRA Distinguished Revolver Match Program

Dates: Saturday and Sunday August 12 & 13 2023. This match will be fired immediately following the completion of the State Championship relay each day.

Who May Compete: All members of the NRA. Competitors under the age of 16 must have waivers signed by a parent or guardian to participate.

Fee: None (Competitors must provide their own ammunition)

Entries Limit: 1 relay of competitors on Saturday and 1 relay of competitors on Sunday. Entry of distinguished competitors may be restricted if range capacity has been reached. Non-distinguished competitors will be given preference. All competitors must certify their eligibility to fire this match. No person may fire this match for practice purposes.

Course of Fire: NRA National Match Course – 30 rounds total

Firearm: NRA Rule 3.1.4 Distinguished Revolver

The revolver must be capable of chambering and firing a 158-grain round nose or semi-wadcutter .38 Special cartridge. It must be a factory manufactured revolver with no external modifications except for stocks which may be modified or changed because of the size of the competitor's hand or to facilitate loading. Exposed holes that have been drilled and tapped for mounting of a scope are not considered to be an external modification.

- (a) Trigger Must have single and double action capability and must be capable of lifting 2 ½ lbs. when the revolver is cocked for single action firing. Triggers will be weighed. Any trigger, sold by the manufacturer of the revolver, without modification, may be used.
- **(b) Sights** Fixed or adjustable rear sights may be used. An adjustable front sight is not allowed. **(c) Barrel** Barrel length not to exceed six and one-half inches.
- **(d) Stocks** Except as set forth above, the right and left stocks must be mirror images of each other. **(e) Ammunition** Any safe .38 caliber ammunition using the 158 grain round nose or semi wadcutter bullet only.
- **(f) The following are not allowed:** Trigger shoes, compensators of any type or design; any external trigger stop device or any internal trigger stop not originally installed by the factory as original equipment in stock revolvers of the same make and model; tape on the stocks, stocks flared at the base or any substance which results in a sticky surface to the stock or hand.

Pistol and ammunition will be weighed and inspected by the Chief Range Officer. All decisions of the Match Director and/or Protest Committee are final.

Awards: As limited by the number of shooters, points will be awarded by the NRA toward the Distinguished Revolver Badge
