- ★ Sunscreen, moisturizer and lip balm
- ★ Inclement weather clothing and gear, we will only suspend range activity if conditions become unsafe!
- ★ Vest, coat or long shirt capable of concealing holstered handgun

ELIGIBILITY: Open to any qualified person using a safe concealable handgun in .22 LR, .380, .38 cal, 9 mm, .40 cal, .45 ACP or other approved Handgun; 20 years of age, with valid FOID card;

By signing, I understand, represent and agree that:

1. I must positively identify myself as the same person certified in the application.
2. Range operations depend on careful control of deadly weapons by each student, and if any time during the course my cooperation is not deemed satisfactory to Triple Threat Defense LLC or Illinois State Rifle Association Range (ISRA Range), my participation will be terminated.
3. I will abide by any and all safety procedures required by Triple Threat Defense LLC and ISRA Range, and I agree upon my arrival, to complete, sign and understand a "Release and Indemnification Agreement" releasing Triple Threat Defense LLC and the ISRA Range from liability for any injury I may sustain or cause during my training.
4. I will be at least 21 years of age at the time of training and of good moral character with no felony record.
5. My only purpose for seeking the training, which I have requested Triple Threat Defense LLC to provide me, is so that I may better be prepared in performing lawful acts for my own use.
6. I consent to having Triple Threat Defense LLC verify my identity and nothing in my history would prevent me from possession or handling a firearm in Illinois.
